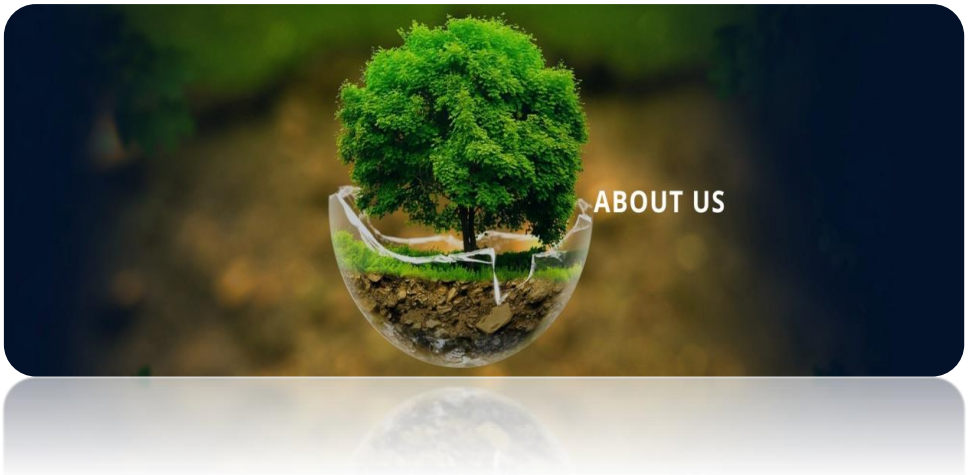

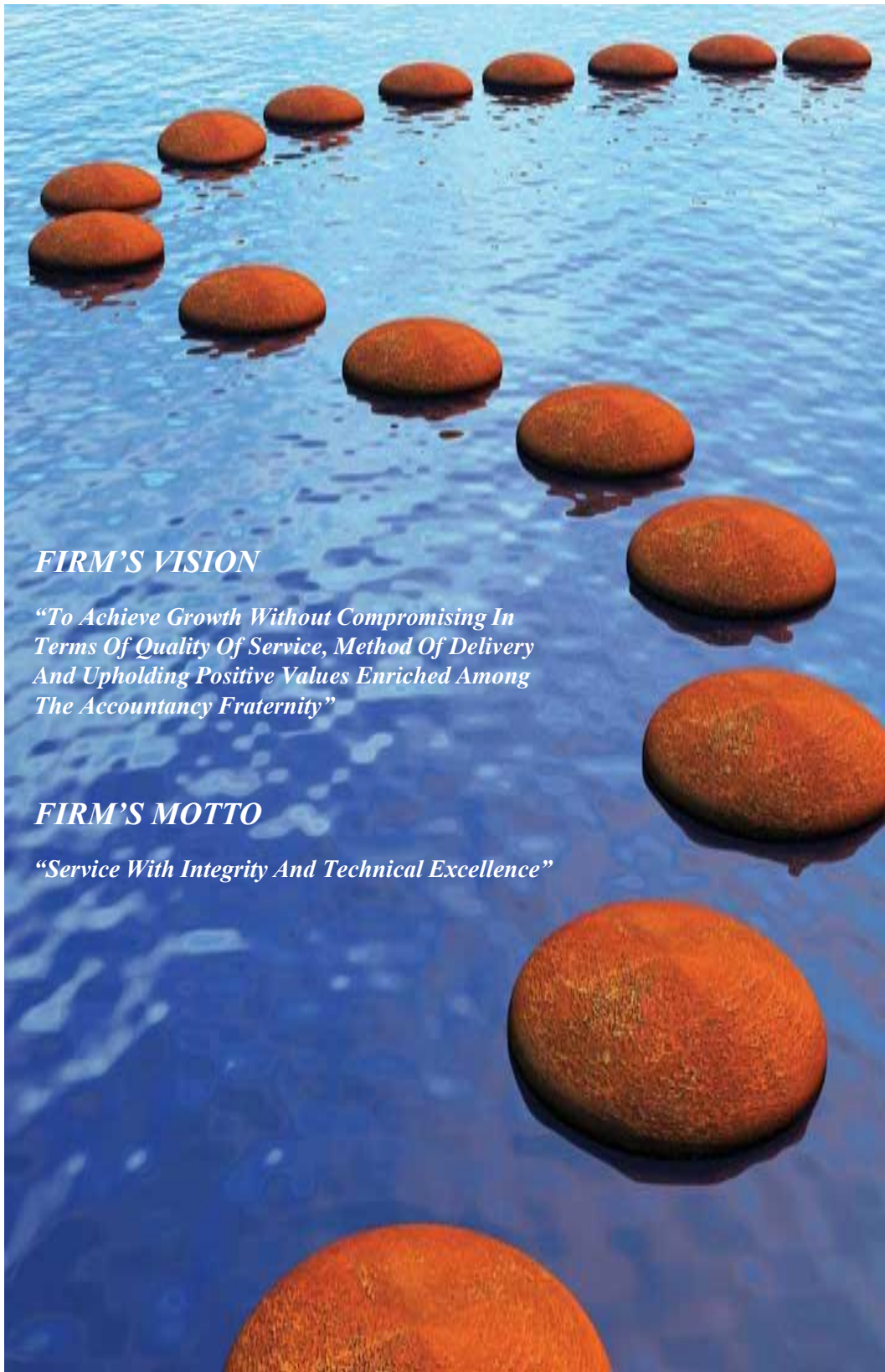


## OVERVIEW

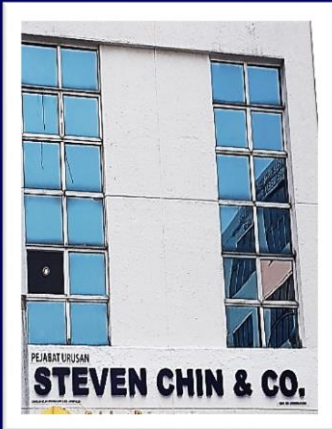
